

## **Examples of Mental Health Training**

Mental Health | CPPE (free to NHS Pharmacy workforce)

A range of learning material on mental health topics

College of Mental Health Pharmacy (course fees apply)

**Psych 1**: Introduction for pharmacists, pharmacy technicians and medicines management professionals to key mental health conditions. It introduces mental health, focussing on the core clinical issues.

**Psych 2**: Aimed at professionals with some limited clinical experience in psychiatric pharmacy practice. An extension to Psych 1 covering more specialised areas.

Primary Care | Safe Prescriber (free with nhs.net email, registration required)

SCRIPT is an eLearning programme, commissioned by HEE, to improve safety and competency among healthcare professionals around prescribing, therapeutics and medicines management

Mental Health | Medicines Learning Portal (free)

Tutorial aimed at foundation level pharmacists but the content is also relevant to clinical primary care pharmacists
